We, the undersigned Incorporators, all of legal age, and majority of whom are residents of the Philippines, have this day voluntarily agreed to form a non-stock and non-profit corporation under the laws of the Republic of the Philippines.

WE HEREBY CERTIFY:

FIRST: That the name of the said association shall be

(as amended on 27 January 2025)

SECOND: That the purposes for which said corporation is formed is:
